## APPELLEE, ORANGE COUNTY, FLORIDA'S RESPONSE TO APPELLANTS' MOTION FOR JUDICIAL NOTICE OF REPEALED AND CURRENT RULES CONTAINED WITHIN THE FLORIDA ADMINISTRATIVE CODE

Appellee, Orange County, Florida, pursuant to Rules 9.110(f), 9.200, 9.210(g), and 9.300 of the Florida Rules of Appellate Procedure, responds to the Motion for Judicial Notice of Past and Present Rules of the Florida Fish and Wildlife Conservation Commission ("FWC") filed by Appellants, David W. Foley, Jr., and

Jennifer T. Foley ("the Foleys") on or about November 2, 2021, and states:

- 1. Orange County objects to the Foleys' Motion for Judicial Notice ("Motion") for the following reasons.
- 2. Motions for judicial notice should not be used as a means to raise additional, last-minute arguments on appeal after all of the briefs have been filed. The Foleys' Initial Brief, Amended Initial Brief, and Reply Brief were filed on June 16, 2021, June 25, 2021, and August 30, 2021, respectively. Orange County's Answer Brief was filed on or about August 9, 2021.
- 3. Now, through the filing of a Motion for Judicial Notice, filed about one month prior to the oral argument, the Foleys attempt to address their concern that pages 5 and 6 of their Initial Brief cited to repealed provisions of the Florida Administrative Code.
- 4. In an effort to correct their Initial Brief and to "resolve any confusion from the Foleys' failure to cite the current rules," the Foleys' Motion attempts to cross-reference portions of text in repealed Rules with portions of text in more current Rules. Motion, p. 4.
- 5. Since the purpose of the Foleys' Motion is to compare and analyze portions of the text in repealed Rules with portions of text in

more current Rules, the Foleys' Motion is not simply the judicial notice of all of the existing provisions in Titles 68 and 68A of the Florida Administrative Code pertaining to the "Fish and Wildlife Conservation Commission" or "Freshwater Fish and Wildlife," respectively. Instead, the Foleys' Motion is an attempt to clarify their Initial Brief and to raise a new argument addressing their concern that the cited provisions in the Florida Administrative Code have been repealed.

- 6. The Foleys' Motion acknowledges that their Appendix does not include all of the current Rules codified in Title 68 of the Florida Administrative Code, entitled "Fish and Wildlife Conservation Commission" or Title 68A entitled, "Freshwater Fish and Wildlife." Motion, p. 4.
- 7. The Foleys' Motion does not include tracking of all of the changes to the Rules from 2010, through subsequent amendments to the Rules, prior to the adoption of the current Rules.<sup>1</sup> In other

words, the highlighted portions of the repealed and more current Rules in the Foleys' Appendix to their Motion have not been presented in the context of the entire Chapter as it may have existed at the time.

8. Thus, for the foregoing reasons, this Court should deny the Foleys' Motion for Judicial Notice.
